# IMAMIA FUNERAL SOCIETY

- Imamia Funeral Society will be formed by all members of Shia Muslims in UK.
- The purpose of the Society is to assist a member(s) towards funeral expenses in the event of bereavement.
- Total cost relating to the funeral will be paid by the Society.
- Any member who dies outside this country his family/next of kin will be compensated to the extent of £1,000.00 or equivalent of the local currency at the country of demise.

## **TERMS AND CONDITIONS.**

- All members must abide by the terms & conditions.
- All members must be Shia Muslims.
- The office bearers will be elected for five years and the governing body will comprise of The President assisted by a General Secretary.
- Membership must be approved by the President.
- All members are responsible for contribution even in case of unemployment/retirement etc.
- Membership will be £ 50.00. (this includes couple/children up to the age of 16) However, it may necessitate additional collection at the time of a member(s) death in order to sustain/maintain funds level of the society.
- The total cost of the funeral expense paid out would be amortized amongst its members.
- All members must pay the membership fee within three months.
- Any member who does not pay his/her membership fee for three months, the Society will cancel his/her membership.
- Society will not refund any membership fee.
- Society will not accept membership from person diagnosed as suffering from serious illness/ disease. Anyone found concealing such information at a later stage for the sake of obtaining Society's membership his/her application would be treated as null and void and any membership fee paid would not be refunded.
- All members must inform to the society in case of any changes in Address/Telephone Number.
- If a death of more than one person occurs simultaneously in the same family, the Society will only pay for the funeral expense of only one family member.
- In the event of a member dying from death other than natural causes, i.e. murder, suicide, the society would not be liable to pay any expense.
- Members claiming funeral expense from Social Security would not be entitled to any funds from the Society.
